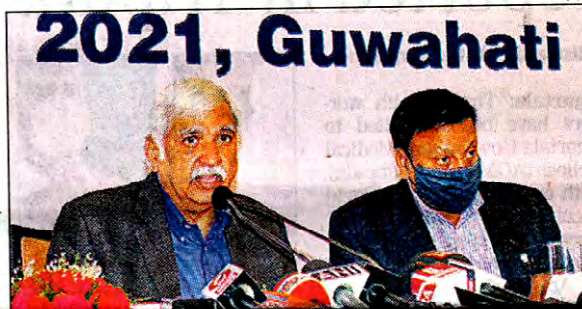

Guwahati: A day after the official announcement of the grand alliance of six opposition parties led by the Congress to oust the BJP in the upcoming assembly election, state president of the saffron party, Ranjeet Kumar Dass, on Wednesday said no alliance will be able to prevent the ruling party from retaining power.

He said the relentless activities of the party and the achievements of the BJP government in the state will make the party's mission 100+ possible.

"The grand alliance of these parties led by the Congress has now opened the path for the party (BJP) to win the ensuing elections with less effort. Now, the battle of ballots will be among BJP, the grand alliance led by Congress and the new regional parties — Assam Jatiya Parishad and the Jaijor Dal — which we will easily win and form the government again," Dass said.

Besides Congress, the other parties that have come under the joint platform are the AIUFD, the CPI, the CPM, the Communist Party of India (Marxist Leninist) Liberation, and the Anchalik Gana Marcha (AGM) led by Rajya Sabha MP Ajit Kumar Bhuyan.

The six parties resolved to fight the forthcoming assembly polls together and also called upon other "anti-BJP" parties to join the grand alliance.
