New Delhi: Former finance minister P Chidambaram on Tuesday blamed "excessive taxes" on petrol and diesel for runaway prices. "Relentless rise in prices of petrol and diesel is not inevitable because the price is built up by excessive taxes on petrol and diesel. If taxes are cut, prices will decline significantly." Chidambaram tweeted as the rupee shrank further to 71.54 against the dollar to push up fuel prices to new highs.
