Minutes of the previous Audit Committee Meeting held on 30<sup>th</sup> May, 2013 were read, confirmed and signed by the Chairman.


2. Fairness Opinion and Valuation Report in respect amalgamation of APL Engineering Service Private Limited with of Amines & Plasticizers Limited.
