Trump plan will run into congressional hurdle'

n fact, some foreigners plan their travel in such a way that they give birth in the US. There has long been speculation that immigration hardliners in the Trump administracion want to can this route. but policy experts have said it will run into congressional opposition and it might not withstand legal challenges

But Trump said he believes it can be done with an executive order: "It was always told to me that you needed a constitutional amendment. Guess what? You don't," Trump told Axios, which first broke the story, declaring he can do it by executive order.

You can definitely do it with an Act of Congress. But now they're saying I can do it just with an executive order,"

The legal challenges to

such an executive order would force the courts to decide on a constitutional debate over the 14th Amendment, which says, "All persons born or naturalised in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside.

Immigration hardliners have argued that the 14th Amendment was only intended to provide citizenship to children born in the US to lawful permanent residents-not to unauthorised immigrants or those on temporary visas.

Michael Anton, a former national security official in the Trump administration, recently argued in the Washington Post that Trump could, via executive order, "specify to federal agencies that the children of noncitizens are not citizens" simply because they were born on US soil.
